POWER LINES UPDATE

After alternately fighting and negotiating with PSE&G for several years, we reached agreement with PSE&G this year, under which we have been paid \$300,000, in return for an easement for a small additional right of way area between the Lake and first tower up the mountain toward Picatinny Arsenal. In addition, PSE&G eliminated a tower from their plans that would have been built near the Longwood Lake Road entrance to the Lake property. The settlement payment reflects a huge improvement over PSE&G's May 2010 offer of a mere \$750.

On February 20, 2013, Vicki Morgan and Jeff Galloway accepted PSE&G's \$300,000 check and deposited the funds in a segregated bank account at Provident Bank. The officers will propose at the June 8 Annual Meeting that a Funds Committee be established to make recommendations regarding use of the PSE&G funds, and that no withdrawals will be made from the funds account until after the LLCOA membership considers and votes on the Funds Committee recommendations.

Our attorneys have advised that care must be taken regarding how the funds are used in order to avoid having the funds taxed. Uses that will likely preserve the funds' tax exempt status include using the funds for maintaining the health and integrity of the Lake, including repair and maintenance of the dam. Dam repair and maintenance is a complicated subject, that will be discussed more fully at the June 8 Annual Meeting.

LLCOA FORESTRY REPORT

As a reminder, and for any newbies, the LLCOA operates a tree farm on about 600 of our 660 acres. This allows us to keep this acreage in a more-or-less wild state while lowering our property tax liability dramatically, compared to what we would be paying if it were assessed as residential or commercial property.

In order to maintain our farmland tax status, we have to show "active devotion to agriculture". This means we can't just leave the woods alone to grow, but must do things a farmer would do, including harvesting and weeding. Back in the 1990s we carried out two substantial harvests of timber, but trees grow slowly and the lumber market has been depressed, so we have not done any recent harvests. In past years a team of us have gone out with chain saws and carried out "timber stand improvement" activities, where we cut out weed trees like witch hazel to leave more room for oak, maple, and ash to grow. Unfortunately, young oaks, maples, and ash have not grown up where we cleared space for them – we say there is little or no "regeneration". The primary culprits are those cute deer you often see in the woods. They are wildly overpopulated, starving every spring, and whenever a tiny tree sprouts, they eat it. So we have been cutting back on the timber stand improvement activities, since there's little benefit.

But we still have to show "devotion to agriculture." Every year we ask members to fill out a form indicating how much fire wood they harvested, and a small part of your annual maintenance is earmarked as a "firewood fee". This allows us to show annual income from the farm. Also, last year we reported some clean-up work that people did after Sandy knocked down many trees, and we will report more of that work as

people have harvested downed trees all around the property. If you have done substantial clean-up of trees downed by Sandy, please send me a note mentioning where you did it and I will include it in the report I must file.

Last year a contractor working for us harvested five mature white oak trees and used them to make the five huge twenty-foot beams that support the new bridge. These would have been practically impossible to buy, and count as a valid forestry activity.

Also last year our professional forester, Duke Grimes, marked out a substantial number of ash trees near the Longwood Lake Road entrance, after approval of this plan by the members and again by the officers. The idea is that the emerald ash borer, an invasive insect that kills ash trees, is in Pennsylvania and headed this way, and it makes more sense to harvest the trees now than to leave them standing until they are killed. Because of Sandy, the local loggers have all been too busy to take on the job, but Duke is hopeful we will get a meaningful bid this summer, with the harvest to follow in the fall.

So our tree farm continues to be a part of our activities, but once again, we will not do a timber stand improvement this summer.

ROADS & BRIDGE REPORT

The roads remained in relatively good shape last year, so no major road work was required.

The bridge, however, was another story. Last fully rebuilt about 15 years ago, the bridge had suffered serious structural deterioration. We contracted with Ed Wendlocher of Wharton to rebuild the bridge.

Ed used five large white oak trunks from our own forest as the main structural support for the new bridge, on top of which he placed new decking and guardrails. Ed completed the new bridge in December 2012.



THERE OUGHT TO BE A RULE . . .

Well, in fact, we do have a few rules – all of which were approved by the full membership of LLCOA. It's important to remember that our rules were adopted at full membership meetings and that they reflect the consensus of our community on how we should treat the property and one another. The areas where we have had the most issues this past year involve ATVs/Dirt Bikes; blockage of fire lanes; generator and other noise; poorly maintained cabins and yards; and improper tree cutting.

ATVs/Dirt Bikes. Motor bikes and ATVs/dirt bikes may not be ridden within 400 yards of any cabin, except for transit to and from a cabin; motor bikes and ATVs/dirt bikes must be equipped with appropriate mufflers. A cabin owner must accompany any guests who are riding ATVs/dirt bikes on LLCOA property. (Rule 17.)

Cabin Construction. Any work that requires a building permit must first be submitted to the Construction Committee for approval. Work performed without such approval is subject to a stop work and/or take-down order. Please contact a member of the Construction Committee (Aaron Lewit, Ronnie Jung or Rich Switaj), *before* you submit any plans to Jefferson Township.

Fire Lanes. These are common land, and may not be used as the “personal” property of any particular cabin owner. The reason we have these lanes is for the safety of all the nearby cabins: the

fire department will use these lanes so that their pump trucks can access the lake for water to put out fires. Please don't park in the lanes, store wood or anything else there, make plantings or place outdoor furniture in these lanes.

Generator and other noise. No electrical generator may be operated as a power source for a cabin unless it is muffled such that it cannot be heard at neighboring cabins, and its exhaust cannot be smelled at neighboring cabins. This muffling is not required for use of electrical generators for construction or other sporadic work during the hours of 9:00 a.m. to 6:00 p.m. (Rule 19.) Cabin owners or guests may not create or permit, inside or outside, any unnecessary or excessive noises or disturbances of any kind; nor the playing of any kind of music or amplified sound in a manner loud enough to disturb other occupants or neighbors in surrounding cabins. (Rule 6.)

Poorly maintained cabins and yards. Each Cabin Lot shall be kept clean at all times, being free of garbage, trash, old lumber, non-operating cars and trucks, etc. Violations are subject to a \$100.00 fine. If a cabin owner persists in failing to correct the violation, then Association may chose to have the condition corrected and charge the cabin owner for the cost of such corrective measures. (Rule 13.)

Improper tree cutting. Trees cannot be cut outside of you cabin lot except as part of an official Association activity, such as road clearance or the timberstand improvement plan. (Rule 4.) Trees on your own lot cannot be cut if they are greater than 6 inches in diameter. (Construction rule 5.) If you need to cut a tree larger than 6 inches in diameter, please contact a member of the Construction Committee (Aaron Lewit, Ronnie Jung or Rich Switaj).

CABIN SALES

As provided in our Master Deed, there is “an approval process with respect to the sale, mortgaging or other transfer of title of the units. This includes but is not limited to requiring the prospective purchaser of any unit to submit an application to the Board of Trustees.”

So what do you do?

1. Get an application from one of the officers by sending an email to longwoodlakecabinowners@gmail.com

2. Have the prospective purchaser fill it out.

3. Give the application to an officer.

The officers will set up an interview with the prospective purchasers. The seller cannot be present. The interview is a two-way process. We want some information from the purchasers, for example to make sure they have sufficient income to afford property taxes, insurance and LLCOA dues and assessments. We also want to make sure that they understand the rules that govern our community.

RECYCLING AND GARBAGE

HIGHLIGHTS

RECYCLING CANS

ONLY commingled glass and plastic (PETE #1, 2, 3, and 5) bottles, jars, jugs, aluminum, tin, and steel cans. Also yogurt, cottage and cream cheese, margarine, butter, containers, etc. (PETE #1, 2, 3, and 5). ONLY these items go into the recycling cans. Everything else goes in the dumpster. Empty all plastic bags, paper bags, 6-packs, boxes, etc..

DO NOT put any garbage, newspapers, paper, cardboard, paperboard, 6 packs of any sort in the recycling cans.

Tie up newspapers, cardboard, boxes, etc. and leave on the ground or put in dumpster.

DO NOT put any plastic bags, supermarket plastic bags, etc. in recycling cans.

GARBAGE (DUMPSTER)

Put all garbage in the dumpsters (preferably in the rear lids). Garbage must not be easily accessible to the bears at the front lids or hanging out of the front lids. Close lids fully and attach the chains. The lids must be closed and chained at all times, no exceptions.

Only household garbage that the township allows a homeowner to put out in front of a house in Jefferson Township is allowed to be put into the dumpsters and at the dumpster area. This garbage and recycling is picked up by the regular township garbage trucks, not a separate contractor.

IMPORTANT: When you leave the dumpster/recycling area, the lids MUST be closed and chained even if you did not open or unchain them. You must close and chain them. It is the responsibility of every member to keep the lids closed and chained at all times to prevent bears from getting to the garbage.

DO NOT LEAVE TV's, Computers, Monitors, Tires, Mowers, Propane tanks, etc. at the dumpster area. See the instructions shown later for these items.

NO CONSTRUCTION MATERIALS

Construction material can be taken to the Jefferson Twp. Recycling Center by appointment, Saturdays between 9:00 am and 1:30 pm. To make an appointment, call 973-208-6100 Monday through Thursday. One level pick-up truckload is allowed per week; bring your tax bill, as proof of residency is required.

NO TIRES. Tires can now be taken to the township Recycling Center for a fee and bring your tax bill, during normal recycling hours. Tires can also be taken to the Parsippany Transfer Station by calling 973 808-9651

NO BATTERIES Batteries can be taken to a place that sells batteries.

NO PROPANE TANKS Tanks can be taken to Eastern Propane for recycling or disposal.

NO MOTOR OIL Oil can be taken to a place that sells motor oil.

NO HAZARDOUS WASTE

Hazardous waste (including motor oil) can be taken to the Morris County M.U.A., by appointment only; call 973-829-8006.

SPRING CLEANING DUMPSTERS

We are trying to have the dumpsters available earlier this year, so please be on the lookout for updates on timing. The dumpsters will be placed in three locations: Freddie's Field, the old dump on the back road and on Yellow Road.

Please adhere to the following rules for the dumpsters:

1. **DO NOT** put any food garbage in the cleanup dumpsters; this is not allowed and will attract skunks, bears and other animals.

2. These dumpsters are for general cleanup only. They are **NOT** for your construction waste or for cleaning out a cabin (this also includes the regular dumpsters). You need to get your own dumpster for this. A mattress, a piece of furniture, an old grill, general debris, etc. is OK. (**NO PROPANE TANKS**).

Break up and flatten items as much as

possible.

Do not just toss items in. Pack them in tightly.

3. **DO NOT** put leaves, branches, logs, etc. in the cleanup dumpsters (or the regular dumpsters or dumpster area); these should go into the woods.

4. **DO NOT** put concrete, cement blocks, etc in the Blue Road dumpsters (or regular dumpsters or dumpster area); these items make the dumpster too heavy.
