DEAR CABIN OWNERS,

It has been a year without precedent in the history of Longwood Lake. When I wrote to you a year ago, the pandemic was in its beginning stages, and we were trying to figure out how to get through it. Now we are, hopefully, in the waning stages of Covid. The disease is not eradicated by any means and there are still dangers to contend with. But I do believe that the worst of it is now behind us, and It is a good time to look back and reflect on how we handled the challenge.

The pandemic forced us to cancel the picnic and the dinner dance. But somehow or other, we continued to keep the wheels of our organization turning. We held our first ever virtual annual meeting last year, complete with our first experience of electronic voting, and managed to get a lot done. So, the focus of my letter this year is more on what we were able to accomplish – in spite of some serious obstacles.

We've become experts at meeting through Zoom. The board has continued to meet monthly and take care of business. I am also always gratified to see how many cabin owners log on or dial in to these meetings. It's a healthy sign that grass roots democracy is alive and well at Longwood Lake.

It's also incredible, and another sign of our organizational health, that every single cabin owner paid their maintenance fees. I think that performance may set a record, but it's a record that I hope we'll continue to maintain. It's true that not everyone paid on time, but eventually, and given a little understanding and flexibility, everybody came through – a tribute to how much we all value the Lake and the Association that sustains it.

The spirit of volunteerism and member participation in work projects is also alive and well at Longwood Lake. Formal committees and informal groups of cabin owners revised our Rules Handbook;

proposed new bylaws; researched our options and strategies for dealing with Jersey City about the dam; organized several days of cutting down Ash trees that had become infected by the Ash borer; organized a clean-up of the dumpster area; managed the completion of the bird habitat project; took care of the hemlocks; and managed to pull off a successful ice fishing tournament. You can read more about much of this further on in this Newsletter. There are so many people who deserve a shout-out, and I look forward to doing exactly that when we meet on June 26 – safely and in person – in Freddie's Field.

ELECTION of OFFICERS

The following Board positions were up for nomination/election this year: Treasurer, Secretary and VP at Large. There were three nominations: Gail Slockett for Treasurer, Eva-Lee Baird for Secretary, and Feliks Kiselyuk for VP-at-Large. All three have accepted a nomination.

TREASURER'S REPORT

The LLCOA Board approved the 2021-2022 fiscal year proposed budget at its May meetings. A PDF of our proposed budget, along with the 2020-2021 budget and actuals, and our financial assets is attached to this email. The board proposes to keep the dues at \$850 if paid by July 31, 2021. They will increase to \$900 if paid by August 31, 2021, \$950 if paid by September 30, 2021, and \$1000 thereafter.

Because of the pandemic we have once again postponed our Dinner Dance. Usually the budget for the Dinner Dance is used up by the end of our fiscal year. However, this year we have only spent 500 for deposits, but will hopefully spend the rest in September. Those funds will come from the 20-21 budget surplus. I have added \$8500 from the surplus to our expected Miscellaneous Income for the 21-22 budget and increased the Dinner Dance budget to \$17500 to account for two Dinner Dances in the same fiscal year. The picnic will be scaled down this year but it is anticipated that we will use all the monies budgeted for it.

I have tweaked a few of the categories in the budget again this year, and have made some changes from previous years. I eliminated the "Capital Improvement" line item and folded it into "Land Management/ Maintenance, Repairs, & Misc." We increased that line item by the \$1000 from capital improvement and added another \$2000 from the general budget. This winter we spent much more on snow plowing than anticipated so we increased that budget to cover future snowy years. We also spent more on Forestry this past year than usual, and have increased that budget as well. Our insurance costs have gone up and I expect them to rise again next year.

We lowered the budget for administrative and annual meeting line items, as well as legal fees and donations. We think the money can be better spent on maintaining our property, and with the bylaws finished we don't expect high legal fees, (except pertaining to the dam which I will address further on).

We spent \$17500 to rebuild the bridge in order to allow trucks and emergency vehicles to access Blue Road. We paid for that out of our surplus and contingency funds. We have two CDs totalling approximately \$190,000 reserved for emergencies, and more than \$52,000 remaining in the contingency fund.

We have spent a little over \$5000 for legal and tax advisors for the Dam out of our money market fund in Provident bank. We currently have \$202,000 in there and a CD for \$104,722 also earmarked for the Dam. All funds are FDIC insured.

In accordance with our past practice and our proposed new bylaws, we are asking for a vote of the membership to approve this budget and the subsequent dues and payment schedule. If you have any questions about the budget you can contact me at ggslockett@gmail.com or call or text 201-543-9702.

Please mail or email a completed and signed firewood affidavit. This is important to support our farmland tax status that saves all of us a substantial amount of money.

In addition, the LLCOA requires all members to maintain at least \$300,000 in liability insurance. However, we are no longer requiring proof.

IMPROVING THE LLCOA HANDBOOK

At the Annual Meeting of June, 2019, the members approved a new version of the LLCOA Handbook, a guide both to our rules and to many of our practices and customs. We knew at the time that the Handbook was somewhat limited. Our Bylaws needed to be updated, and since the rules must agree with the Bylaws, the Handbook would need to be updated once the Bylaws were. The members approved the updated Bylaws at the (online) 2019 Annual Meeting, and since then the Rules Committee has

worked to develop an improved Handbook with these goals:

- Make sure all the rules in the Handbook are consistent with the Master Deed and its two Amendments and the 2019 Bylaws;
- Correct a few minor errors that were made in the 2018 Handbook;
- Introduce a few proposed new rules, suggested either by Rules Committee Members or by other members; and
- Suggest a set of substantial fines for violation of a few important rules and make abatement of violations legal.

Some of these proposals will be controversial, including the existence and size of fines, or some proposed changes to construction permitting procedures. Also new is “abatement” the idea that the LLCOA can “abate” a violation by correcting, for instance, a condition that violates a rule and then bill the responsible cabin owner for the work. ANY CONTROVERSIAL ITEMS WILL ONLY BECOME RULES IF THEY ARE VOTED IN INDIVIDUALLY BY MEMBERS.

Starting in late May, the Rules Committee sent drafts of the new Handbook to all members, with all changes clearly marked, for your review and to gather your reactions. You may also be invited to participate in an Internet poll to gauge member feeling on particular proposals. Then, as part of the Annual Meeting, members will vote individually on any changes that have been found controversial, and then to accept the Handbook including the approved controversial items. You will receive a lot more email about this, setting out many details. Please pay attention to this process, as it will determine the rules under which we will live for a long time to come.

LONGWOOD LAKE DAM REPORT

At the October 2020 Annual Meeting, Dam Committee Chair Jeff Galloway reported that the Longwood Lake Dam's owner, Jersey City, is actively exploring taking down the Longwood Lake Dam. Without the Dam, there would be no Longwood Lake. This would obviously be a calamity for our community. Jeff reported that the Jersey City Municipal Utilities Authority (JCMUA) had commissioned an “Alternatives Analysis” to explore alternatives for Jersey City to meet its maintenance and repair obligations for the Dam. Those obligations had increased because of the Dam’s recent reclassification from Low Hazard to High Hazard. (High Hazard does not mean that the Dam is at greater risk of failure; High Hazard simply means that if the Dam did fail, there would be a high risk of loss of life or property downstream of the Dam.)

Since last October, the Dam Committee has been working with our lawyers (Eileen Born on Dam issues, and Stan Epstein on related tax issues) and with our engineer (Paul Fox) to develop and implement a strategy for preserving the Dam. We are cautiously optimistic that we will be successful in preserving the Dam.

In February 2021, JCMUA submitted its Alternatives Analysis Report (AA Report) to the Dam Safety Division of the New Jersey Department of Environmental Protection, who then provided a copy of the AA Report to us. The AA Report describes two alternatives for Jersey City to meet its maintenance and repair obligations: (1) a rehabilitation project to shore up the dam, reducing the risk of Dam failure in the event of severe weather events, and (2) decommissioning the

dam, which would involve removing the Dam and allowing what is now Longwood Lake to revert to its historical state as a section of the Rockaway River. Our engineer is working on developing cost estimates for these two alternatives. The AA Report is written in a way that suggests that JCMUA believes that the decommissioning alternative will be less expensive than rehabilitating the Dam, but our engineer cautions that decommissioning often involves substantial remediation costs that could be greater than the cost of repairing the Dam.

The next steps in Jersey City's Dam alternatives evaluation process will involve NJ DEP's review of the AA Report, likely followed by questions and comments from NJ DEP to JCMUA addressing areas of concern for DEP. Once these concerns are addressed, JCMUA would decide on which alternative (repair or decommissioning) it wishes to pursue and then begin putting together the actual designs and plans to implement that alternative. If Jersey City decides it wants to decommission the Dam, public hearings would be held regarding that alternative before any work could begin.

Our intention is to open a dialog with Jersey City before Jersey City comes to any decision point, with the objective of assuring that the Dam gets repaired rather than decommissioned. Jeff will report in more detail at the Annual Meeting.

FORESTRY REPORT

As an introduction for new folks, we own about 680 acres, and 660 of those are classified as farmland, a

tree farm from which we harvest large mature trees and sell them to lumber mills, and gather firewood from dead trees. We've been doing this since we bought the property, and it saves us a lot in taxes as well as providing useful income. The low-tax farmland status is governed by NJ state laws, and we have to show "devotion to agriculture" every year.

For harvesting saleable timber, we set up contracts with loggers, while for smaller, year-by-year work, teams of LLCOA volunteers do the work. In the past, we often did "timber stand improvements," where a team of volunteers cut down weed trees, leaving more space for the valuable trees to grow.

This year we had to face a problem. Three or four years ago, gypsy moths killed many oak trees, especially white oaks. And over the last few years a different invasive insect, the emerald ash borer, has been killing ash trees. This left us with a large number of very large, dead or dying trees along LLCOA roads where they could fall and at best block the road and at worst fall on a vehicle or person. With Board approval, a team led by Paul French (206) and Feliks Kiselyuk (116) brought down 28 of these that we considered dangerous, and cut them up enough to get them off the roads. This wood is piled along Grey Road (the AT&T Right of Way), the end of Orange Road near Grey Road, on Easy Street (off Grey Road), and on the unnamed shortcut from near the gate up to Grey Road. There are several cords of good wood, waiting to be collected by any cabin owner. You will need a chain saw to get the pieces down to convenient

sizes, and some of it will have to be split. Please help yourselves!

Our second issue this year is that Duke Grimes, who has been our professional forester since we bought the property, has retired and we must find a replacement for him. New Jersey has a list of approved foresters, and the Forestry Committee (see the roster) will work from that list to identify a forester who can best meet our goals of sustainable forestry, farmland tax status, and compliance with the assorted rules we must follow. We have one suggestion from a member, and if any of you have a forester to recommend, please contact the Committee. We will consult with the Board and let the Association know when we have chosen someone.

HABITAT COMMITTEE REPORT

The contract for our Early Habitat Improvement Project funded by the Natural Resources and Conservation Service (NRCS) of the US Department of Agriculture ended in 2020. The timber stand cut we did at the start of the project, which netted us a very hefty sum, helped our two target areas produce the desired early forest habitat. New Jersey DEP, NJ Audubon scientists, and other biologists associated with their programs, will continue to monitor the habitat improvement target areas we created in the LLCOA forest.

This past May two Whippoorwill monitoring recorders were placed in Target Area 1 (up the mountain) and on June 3rd a bird survey by DEP and NJ Audubon was scheduled, and hopefully it was completed by the time you get this newsletter. The

scientists involved remain very optimistic about finding the endangered Golden Winged Warbler on our property. I will keep you updated as to upcoming survey walks and any exciting new findings.
